Minutes: Commissioner Clark made a motion to approve the April 1, 2019 Minutes. Seconded by Commissioner Sanders and unanimously approved by the Board.

Conditional Use: Commissioner Norman made a motion to approve the application submitted by Buddy Robinson, Jr. for a conditional use to construct a 400' Telecommunications Tower on 6.0275 acres on Elberton Road within Tax Parcel 161 022. Seconded by Commissioner Saxon and unanimously approved by the Board.

Rezone: Commissioner Sanders made a motion to approve the application submitted by William and Karen Wade to rezone their property located at 22 O'Kelley Road, also known as Tax Parcel 065 064, from AR to R1 in order to create a lot for a residence.
